You do not need to be registered disabled to qualify for some type of adaptations we carry out such as

- stair lifts,
- ramps,
- hand rails,
- level access showers

If you suffer from some form of disability and feel that an adaptation may be of benefit to you, please initially contact your Housing Officer for further information. We will discuss with you the sort of assistance you need, and whether it is possible in your home.

Minor Adaptations

We will install most minor adaptations where possible at your request; to help you stay in your home independently without an occupational therapist's (OT) recommendation. Minor adaptations can include the fitting of:

- Grab rails, concrete ramps
- Specialist window openers
- Lever taps to washbasins, sinks and baths
- Entry phones, door release intercoms

Aids and Adaptations

Major adaptations

Major adaptations include:

- Stair lifts,
- Ceiling hoists
- Over bath showers and tiling
- Level access showers
- Non-slip flooring for showers
- Close-o-mat toilets
- Large ramps and handrails
- Relocation of plug sockets and light switches.

We will require a supporting letter with recommendations from an Occupational Therapist from your Local Council's Social Services Department. Once we receive the recommendation, our Stock Improvement department will carry out an assessment for a number of factors:


- The recommendation will be assessed for general suitability or practicality.
- Where a large amount of work has been requested, and a move may be more suitable.
- Whether the works provide a long-term solution, particularly in a case where a large amount of expenditure is envisaged.
- Whether the items should be provided by Social Services, e.g. bath or shower boards..

Once we have carried out the assessment, and assuming the works will be proceeding, We will provide regular updates to inform you of the timescale you can expect for completion.

All major adaptations require an Occupational Therapist's recommendation and specification or details of equipment

Due to the fact that some specific aids and adaptations require ongoing servicing and possible replacement in future years, the Association may have to apply a service charge in addition to the basic rent.
